- 2015 Schooling Shows
  - o Dates published on Website: April 4, May 30 & 31, July 18, August 8, September 19 and October 17.
  - Rain Dates: Beth Huff moved that the Sunday following the Saturday Schooling Show date be declared the Rain Date. If the inclement weather precludes conducting a show on Sunday, the show will be cancelled and the CTDA Cancellation Policy followed. Jen Thompson seconded the motion, which carried unanimously.
    - As venues are confirmed, CTDA will request that the Sunday after the schooling show date be offered as a rain date.
