CTDA Schooling Show Information

CLASS INFORMATION:

Classification: Traditional, Walking Horse, Western, Eventing

All classes will be offered in all classifications, including Pony Club Greenie Weenie (Traditional). If you have questions, please contact secretary.

Divisions: U-13 (13 and under), JR/YR (14 -21 years), Adult Amateur (over 21 on 12/1/14) and Open. Clearly state level and test for the classification you are entering.

If a class is not filled, CTDA reserves the right to combine divisions (scores toward year-end-awards will count in rider's proper division). Western classes will follow USEF rules MO179 & MO180 with regard to attire and equipment EXCEPT *protective headgear is required*.

ENTRY INFORMATION:

Class fees: \$15 each members, \$20 each non-members

Office fee: \$7 per entry (non-refundable)

Facility fee: \$15 per entry (non-refundable)

Stall fee: See www.tndressage.com for each show for further information or contact secretary.

Late fee: If received after the closing date and space is available: \$10 per test.

GENERAL INFORMATION:

Rides will be accepted on a first come, first served basis with a limited number of rides available. Limit 3 rides per horse per show.

Scheduling requests will be honored, if possible, on first come, first served basis, but will require a \$10 per test fee paid with entry.

If the facility owner and CTDA show secretary recommend cancelling due to weather, the "rain date" will be the next day (Sunday). If weather is again an issue, the show will be cancelled.

Payment must accompany entry. *No refunds after closing date for any reason or for weather or safety issues that require management to cancel classes or day(s) of competition.* If the show is cancelled due to weather or safety issues, management will automatically apply the class entry fee(s) toward a subsequent CTDA schooling show in the same calendar year. Otherwise, upon written request by the competitor to show secretary, class entry fees will be refunded. *To accommodate work done by the show secretary and facility, office and facility fees are not refundable or transferrable for future shows.*

Information about warm-up and competition arena will be made available on the website. Check your email for scheduling and other information.

Ribbons will be awarded for 1st thru 6th place. All tests and ribbons must be picked up at the show.

Music for freestyles must be on a CD or cassette tape with written instructions on when to cue the music and turned into the show secretary no less than 1 hour before the start of the freestyle class.

Attire is casual but participants are expected to wear proper headgear and footwear when mounted. All horses must wear their assigned bridle numbers at all times.

No dogs please! All children under 16 must be supervised!

Opening Date is one month before the show. Closing date is IN SECRETARY'S HANDS 7 DAYS PRIOR TO THE SHOW!! AFTER CLOSING DATE LATE FEE WILL BE CHARGED—NO EXCEPTIONS! A copy of negative coggins within 12 months must be sent with first entry or presented at check-in. Copies will be kept on file and need not be sent with subsequent entries unless they become invalid. Please do not bring horses suspected of having a contagious disease. Ride times will be available Thursday before each show on the website:
