Three in One Divisions

1D. Starter:

2015 USDF Intro Test B; Max. Cross Country Height **18”**
Max. Stadium Jumping Height **18”**

2D. Baby Novice:

2014 Beginner Novice Test A Max. Cross Country Height **2’**
Max. Stadium Jumping Height **2’**

3D. Beginner Novice:

2014 Beginner Novice Test B Max. Cross Country Height **2’ 6”**
Max. Stadium Jumping Height **2’ 6”**

Dressage Tests to begin at 8:00 a.m. followed by

Cross Country Course – 1 mile, 17 jumps with an “optimal time window”.

Stadium Jumping – Around 2 PM, depending on number of entries.

Show Limited to the First 20 Horses

The 2015 USDF and 2014 USEA tests will be used



Cross Country Pinnies and Protective Vests must be worn in Cross Country and Stadium Jumping.

NO DOGS ALLOWED IN SHOW GROUNDS!

Cross Country Course is a 1.02 miles course with 17 jumps and flat, downhill and uphill areas. There are blue markers at ¼, ½ and ¾ of the course to provide the rider with a way to adjust for time. **THIS IS NOT A RACE.** There is an optimal time window for each division. Scores will be assessed by closeness to the optimal time (0.6 faults/sec below and 0.4 faults/sec above) USEA’s rule for “Willful Delay” or wasting time on purpose will be applied.

Stadium Jumping will be done in a secure field with 10 jumps (one combination) at the level of each division. Jumping will not be timed. Faults will be applied only on refusals and rails down.

ENTRIES – Entries must be postmarked by closing date and will be accepted in order up to scheduling limit of show (20 Horses). **Negative coggins is required by State Law and each rider is responsible for having it available upon request.**

CLASS FEES – Three in One Divisions \$60 per division, Office fee: \$10.00 per horse/rider combination includes take home number Pinnie which must be worn during Cross Country and Stadium jumping.

REFUNDS - Prior to closing date - less \$10 office fee. **NO REFUNDS AFTER CLOSING DATE of August 26th, 2015.**

AWARDS – Trophies, Ribbons or Medals to 6th place for all classes.

JUNIOR RIDER - Riders under 18 years of age as of the date of the show.

RIDING TIMES - Available by phone at 615-746-4308 on September 3th between 8 & 10 p.m. and also posted the Rojas Ranch Website: www.RojasRanch.com. Times will be e-mailed to competitors on same date or earlier if a legible email address is in entry form.

ARENA – Dressage arena **20m x 56m** outdoor arena – blue stone footing.
COURSES – Cross Country and Jumping Courses held on grass.

DRESS/ATTIRE – A helmet and heeled boots **MUST** be worn when mounted at any time. Riders will be required to wear a protective vest for Cross Country course and Stadium Jumping.

DIRECTIONS – From **Springfield** come out Hwy 49 towards I-24 about 7-8 miles, you will pass Coopertown School (left) and Oak Point Subdivision (right). Right after Oak Point there is a street on the right named **YORK Rd.** (On the left is called **Ewell Elliot**) Turn **right** into **YORK Rd** and go just about 1/4 mile and the first street on the right is **HENRY GOWER RD.**

Or From **Clarksville**, take I-24 towards Nashville, to Exit 24, get out on Exit 24 (Springfield-Ashland City) and go **left** on Hwy 49, in about 1.7 miles there is a street on the right called **Ewell Elliot**, and on the left called **YORK Rd.** Turn left into **YORK Rd** and go just about 1/4 mile and the first street on the right is **HENRY GOWER RD.**

Or From **Nashville**, take I-24 towards Clarksville, to Exit 24, get out on Exit 24 (Springfield-Ashland City) and go **right** on Hwy 49, in about 1.7 miles there is a street on the right called **Ewell Elliot**, and on the left called **YORK Rd.** Turn left into **YORK Rd** and go just about 1/4 mile and the first street on the right is **HENRY GOWER RD.**

.....Then turn Right into Henry Gower Rd and go about 2 miles to a big blue barn on the right side and a white fence. Driveway is at the end of the fence #2571. Name **ROJAS** is on the mail box.
