**LEVELS:** USDF Introductory through FEI Grand Prix, current editions

**Entries** accepted on a first come basis by postmark and/or date stamp on on-line entry. Management reserves the right to combine or divide classes, add or substitute judges, or make changes as required by circumstances.

**AWARDS:** Award (in classes of three or more) and six ribbons.

**Tennessean and Express Dressage Awards :** High Score for each Level and Division, Intro through Fourth Level. High score FEI for each Division. (with at least three horse and rider combinations) (High Score does not include Freestyle at any Level.)

**Master's Classes:** Register in awards office for High Point award. Open to entries in which the combined ages of Horse & Rider equal at least 65 years on the date of the class. Riders are responsible for signing up in the awards area. Award will be given for “**Express**” and “**The Tennessean**”.

**USDF/Dover Saddlery Adult Amateur Medal:** First place Adult Amateur in classes #223 and #323 (minimum score of 60%).

**Jockey Club Thoroughbred Incentive Program (T.I.P.)** will award High Point ribbons and prizes for the following levels/tests: Intro through Fourth Level, and a sash for over all high score Thoroughbred. Only Thoroughbreds that have been registered with The Jockey Club or a foreign Thoroughbred stud book recognized by The Jockey Club are eligible to participate in the T.I.P. Awards. Riders and owners should obtain a T.I.P. number for all horse/rider combinations. T.I.P. numbers applications are done online at [www.tjctip.com](http://www.tjctip.com) and should be completed before checking in at the show office.

**PONY MEASUREMENT:** will be available on the grounds. If you want your pony measured at the show you must contact Mary Cokeing ([mecokeing@yahoo.com](mailto:mecokeing@yahoo.com)) in advance to arrange a time. Tentative time will be Friday after 5:00 PM. The Vet must be present with the TD, so scheduling is important. **Please note:** pony cards are not permanent until your pony is eight years of age.

## Adult Regional Team Competition Rules

^Competitors MUST be Adult (A rider may compete in an Adult Team Competition from the beginning of the calendar year in which they reach the age of 22.)

^The USDF Adult Regional Team Competition is a unique show for adults, featuring team competition in dressage, educational programs, team medals and a mounted awards ceremony.

^A team may consist of three or four riders. Mixed level teams are allowed. There are no qualifying scores needed to be on a team. You may enter as part of a team or as an individual and be added to a team. A team may represent a dressage club, farm, barn, instructor, or be a group of individuals. Any individual or partial team needing team members is encouraged to send in their entry and a mixed team will be formed. To enter contact the entry secretary via e-mail or a note on your entry (See important information segment).

^On the day(s) of the Adult Regional Team Competition, the horse or pony, while on the show grounds (including the stabling area), may only be ridden by the adult rider(s) that will be competing that horse or pony. If the team competition is held in conjunction with an open competition, then on the day(s) of the Adult Team Competition the horse or pony may only be ridden by the Adult Rider(s) competing in the team competition.

^All USEF/USDF competition rules apply.

**TESTS:** Each competitor will ride two tests in their division. Riders competing in FEI divisions will only ride one test. All tests will be current issue.

**TEAM NAMES:** HAVE FUN!!

**AWARDS:** USDF rider team neck ribbons will be awarded for first through sixth place in each division. (Divisions will be determined by participation.) Standings will be determined by the average of each team's total score. Any division with more than six teams will be split. USDF Rosettes will be awarded to the **individual** high score champion and reserve champion in each division. *Riders will be expected to be dressed in riding clothes and mounted for the awards ceremony.*

**SCORING:** The Lowest score will be dropped if it is a four member team. If only three members on a team than all scores will count. Total score from each of the three team members will be added together and divided by three (3)(an average) to compute team placings. Three and four member teams may be in the same division.

**IMPORTANT INFORMATION:** There will be a team meeting on Friday evening (early), details will be posted. All team competition will take place on Saturday. There is no fee to compete on a team. In addition to your normal entry form, please submit a note indicating your intention to be on a team specifying the classes to include in team competition. Include (if you can) team name and names of other team members. If you want to be assigned to a team please indicate. We encourage all eligible competitors to join a team and join in the fun. If you need additional members to fill out your team we will arrange as possible. Team competition forms will be finalized at the Friday meeting. Scores will be posted in the secretary's office. Please check them early and often to see how your team progresses!

**MOUNTED AWARDS** ceremony will be held Saturday evening.

**ENTRIES:** *Entries can be completed online at [www.EqEntries.com](http://www.EqEntries.com) or by completing the entry form included at the end of this prize list. You can pay online with a credit card or print and mail your entry from EqEntries with a personal check. If you chose to pay online there is a 5% handling fee charged by Equestrian Entries. There is no charge to join EqEntries, create an entry or print an entry. So if you chose to print and mail your EqEntry and pay by personal check, the service is free. **Each Entry** must have copies of All Required Documentation attached (USDF/USEF membership, a legible negative Coggins Name of horse matching

entry or 30 Day Health Certificate, *If your horse is from out of state Health Cert. is required*). Include LEGIBLE e-mail address and phone number on entry. *Acknowledgements of entry receipt and notification of problems with the entry will be emailed to the address that you provide. PLEASE READ AND RESPOND!*

**MAKE CHECKS PAYABLE to “CTDA”** and mail with entry, to Entry Secretary, Mary Cokeing. Entries must be received by the closing date.

**Returned check policy:** Void entry and incur a \$25 charge. Entries placed on a waiting list until a money order, certified check or cash is received.

**REFUNDS:** . Full refund less \$35.00 office fee if scratch is received by May 31, 2016. After May 31, 2016: Q fees, USEF fees, and extra bedding refunded for notified scratches. No class or stabling refunds after May 31, 2016, including classes cancelled due to weather, terrorism, or acts of God. No refunds after May 31, 2016 or after start of competition.

Post entries, if accepted, will be placed on a waiting list to fill scratches. Express deliveries can be sent to the physical address 2430 N Reid Hooker Rd Eads, TN 38028. Be sure to specify “no Signature Required” in case the secretary is away at time of delivery.

**GUEST HORSE:** Non Competing horses are welcome. Send a completed entry form and \$25 guest horse fee plus \$35.00 office fee. Submit a current negative Coggins or 30 day health certificate (USEF Rule GR845 proof of vaccination applies to guest horses) . Pay either stabling or day parking. When warm up areas and lunging areas are busy give way to competing horses or come back at a less crowded time.

**MUSIC FOR FREESTYLES** must be provided by the competitor to the announcer at least 2 hours before the freestyle class. Freestyle entries must include a copy of a test scoring over 60% at the highest test of the level.

**TIMES:** Official times posted Friday, June 10th at show office. Unofficial times posted Tuesday before the show at [www.tndressage.com](http://www.tndressage.com).

**STABLING:** *Put all stabling information and \$\$ on the EXPRESS Entry if you are entering both shows.*

Permanent 10 X 10 stalls, with half doors. Center Aisles must not be blocked with hay or equipment. Barns have wash racks. Additional feed and shavings available for purchase upon arrival at the facility.

If you wish to be stabled with others, please specify ONE GROUP NAME for everyone, on the entry.

**Coggins and Proof of Vaccination Requirements USEF Rule \*GR845**

As of December 1, 2015 every competitor entering the show grounds must carry with them, and be prepared to show on demand, proof of vaccination for EHV-1 and Equine Influenza within the past 6 months, and proof of a negative Coggins test within the past 12 months, from the date the show opens. Anyone unable to provide such documentation may be asked to leave the show grounds within one hour. Coggins must be legible, show the date and the negative result, and be in the name of the horse as it is entered on your entry.

**\*GR845 Equine Vaccination Rule**

1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhino- pneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.

2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration.

3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.

4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.

5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee. BOD 1/17/15 Effective 12/1/15.

**Acceptable Health Documentation may include one of the following:**

- 1.) 30 Day Health Certificate with date of Coggins and date of vaccination included. (with entry) This would be the preferred documentation by the show office.*

- 2.) Separate Coggins (with entry) **and** Proof of vaccination (to be shown if asked).
- 3.) Separate Coggins (with entry) **and** Letter from veterinarian on their letterhead stating date of vaccination (to be shown if asked).

All documentation must be legible and clearly state the name of the horse as entered in the show.

**ACCOMMODATIONS:** Sleep Inn at Moores Lane Exit. Accepts pets. 615-376-2122. Many national chains at I-65 exit Cool Springs. Sleep Inn, Marriot Courtyard, Residence Inn, Wingate, Hyatt and others at nearby exits. All are about 10 minutes from the facility. Book Early. This is a VERY busy time around Nashville and Shelbyville. Book Early. Book Earlier.

**DIRECTIONS:** From Nashville on I-65 take Exit 68B for Cool Springs Blvd. West. Merge onto Cool Springs and go 1.5 miles. Turn right onto TN397 N—Mack C.Hatcher Memorial Parkway. Go 2.5 miles and turn right onto Hillsboro Road. Go .3 miles. Brownland Farms is on your left.

**ARENAS: Competition:** 20 X 60 meters, Three outdoor. **Warm-up:** outdoor. Separate area for lunging. All competition and warm up arenas have sand mix footing . Rings open for schooling Friday until 7pm weather permitting. Warm up arenas are available at all times.

**HOSPITALITY:** Concessions (Good Food) available on grounds. Enjoy watching classes from the long shaded shelter between the arenas.

**OPPORTUNITY CLASSES:** These classes are exempt from required USEF and USDF fees for horse, rider, trainer, etc. Entries in opportunity classes may ONLY cross enter into Introductory classes.

**EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.**

**OTHER: Facility Management requires all mounted riders to wear an approved helmet.**

**Headgear:** From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes

and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted. Unless jackets are waived, while in the competition ring, exhibitors wearing protective headgear must wear a short, dark jacket, dark tailcoat (only permitted for tests above Fourth Level), or Armed Services or police uniform (if eligible), dark hat covers (where applicable) and must otherwise conform to DR120

**Minors who do not have a valid driver's license** which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. (see GR801)

### **ENTRY DOCUMENTATION REQUIREMENTS FOR NON-QUALIFYING RIDES:**

- Current USEF membership (or n/m fees) for Rider, Owner and Trainer, Coach
- Current USDF membership (or n/m fees, number) for Rider and Owner. **Rider's USDF membership may be either Participating or Group, Owner's USDF membership may be Participating, Group or Business; if Rider/Owner's USDF # is a non- member ID #, the USDF non-member fee must be paid.**
- USDF Horse ID.
- Current negative Coggins and proof of vaccinations as per Rule GR845 or 30 day health certificate. (Current FEI Passport acceptable).
- For Adult Amateur classes - USEF membership card must declare Amateur.

- Juniors and Young Riders must include birthdate.
- Freestyle entries - copy of a 60% + at the highest test of the MFS level or higher.

**FOR GAIG / USDF QUALIFYING CLASSES ALSO INCLUDE:**

- Check "Qualifying" and add \$10 per Qualifying class.
- Copies of USEF and USDF Horse Registrations (not HID #s).
- Rider must have current Participating USDF membership; Owner must have current Participating or Business USDF membership.
- Rider and Owner, must have current USEF membership.

**ALL ENTRIES** must have **THREE SIGNATURES** - Rider, Owner and Trainer Legal Guardian must sign for riders under 18 yrs. Trainer blank must be signed by person over 18 who assumes responsibility for horse. (Parents who sign as trainer are exempt from membership requirements).

**USEF MEMBERSHIP STATEMENT**

**Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule:**

**1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes**

All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final. Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise. The management reserves the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit entries and cancel award prizes without claims for damages; to

cancel or combine unfilled classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges. Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees. Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste. No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform. It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitably presented to appear before an audience.

## ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

### This competition is recognized by USDF for 2016

**USDF Membership Benefits:** USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at [www.usdf.org](http://www.usdf.org).

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse

Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

### Memberships Defined

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$75), 5-years (\$300), or life (\$1,500). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$60). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards, Great American Insurance Group/USDF Breeders Championship Series Finals and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$200) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Education Membership (EM):** A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$25 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$25). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$70. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$95) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

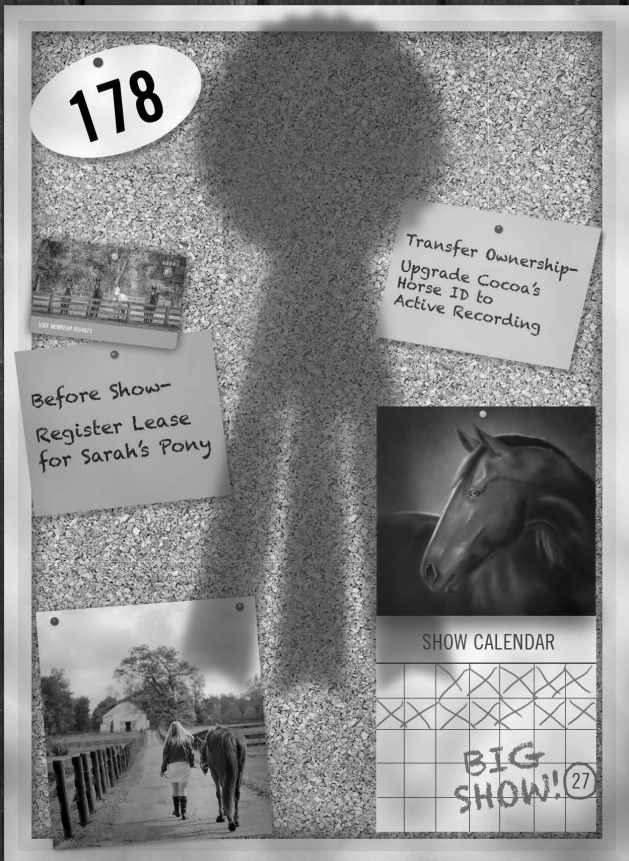

# *USDF Statement on Animal Welfare*

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.
